Risk Statement

Rule 4 of the Racing Rules of Sailing states “The responsibility for a boat’s decision to participate in a race or continue to race is hers alone”

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By allowing my child to take part in this event I, the competitor and the parent/guardian of the child mentioned above agree and acknowledge that:

- a) I and they are aware of the inherent element of risk involved in the sport and accept responsibility for exposing my child to such inherent risks whilst taking part in this event;
- b) I have satisfied myself that my child has the necessary skill and knowledge to take part in the event and to deal with conditions that may arise in the course of a race;
- c) I will not allow my child to participate in the event whilst under the undue influence of alcohol, drugs or whilst otherwise unfit to participate;
- d) The boat is in good order, equipped to take part in the event and they are fit to participate
- e) I am responsible for my child’s property whether afloat or ashore;
- f) I and they accept responsibility for any injury, damage or loss to the extent caused by my own actions or omissions or actions or omissions of my child;
- g) the provision of a race management team, patrol boats and other officials and volunteers does not relieve me of my parental/guardianship responsibilities or my child of his/her responsibilities;
- h) the provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- i) I consent to my child participating in drug testing procedures and if asked providing a urine sample under observation for analysis at an accredited laboratory;
- j) My child and I are bound by the Notice of Race, Sailing Instructions and Racing Rules of Sailing and have been made aware of Rule 3
