



Notice of Race

Streaker Class Association Open Meeting Sunday 8th May Snettisham Beach Sailing Club, Norfolk.

Organising Authority: Snettisham Beach Sailing Club in conjunction with the Streaker Class Association.

1 RULES

1.1 The regatta will be governed by the rules as defined in The World Sailing Racing Rules of Sailing 2021 – 2024, save that Rule 41 (relating to the prohibition of outside help) shall be amended so that a boat receiving assistance with recovery following a capsize or gear failure will not be disqualified if the assistance does not materially or significantly improve her position in the race

1.2 The rules of the Streaker Class Association will apply

1.3 The Regatta is designated category "C" under the Racing Rules of Sailing (RRS.)

1.4 The Exoneration Penalty (and the Advisory Hearing and Arbitration procedures) of the RYA Rules Disputes Procedure will be available.

2 ELIGIBILITY & ENTRY

2.1 Any sailor entering must be a current member of the Streaker Class Association.

2.2 We would appreciate Entries being made before the event, eligible boats may enter by completing an online Entry Form, electronic payment information will be provided in a separate notice. Cheques should be made payable to 'Snettisham Beach Sailing Club' and sent to:- Adrian Tebbutt, 58 Woodland Gardens, North Wootton, King's Lynn, PE30 3PX. to be received by 6th May 2022.

2.3 After this date please bring a completed entry form to registration. Cash or electronic payment, no cheques.

2.4 Parent/Guardian Declarations: All sailors under 18 years of age during the event shall submit signed Parent/Guardian Declarations at registration.

2.6 Competitors agree by entering that they will at all times abide by the currently in force government guidance in relation to Covid19. The competitors agree to comply with the posted notices and signs on the SBSC club premises and the guidance provided by the organisers at registration. The competitors accept that this is their personal responsibility and contravention will not be grounds for protest.

3 FEES

3.1 Entry fee per boat: £20.00

Entry fees for Youth competitors (aged under 21 years in full-time education on 1st May 2022):-

4 REGISTRATION:

4.1 Competitors can register in the SBSC clubhouse between the following times:
Sunday 8th May 2022 from 0800hrs – 1000hrs

4.2 Dates of racing and races scheduled:

3 races are scheduled. Sunday 8th May 2022 however tidal conditions may result in this number being reduced

4.3 The scheduled time of the warning signal for the first race on:-

Sunday 8th May 2022 is 09:55.

4.4 The warning signal for the last race on Sunday shall be no later than 11.45.

5 MEASUREMENTS

Boats and equipment may be inspected at any time for compliance with class rules

6 SPONSOR ADVERTISING

Boats will be required to display advertising supplied by the organising authority.

7 SAILING INSTRUCTIONS

The sailing instructions will be available on the Streaker Association website, the Snettisham Beach Sailing Club website and a limited number at registration.

8 SCORING

8.1 One race is required to be completed to constitute a series.

8.2.1 When fewer than four races have been completed, a boat's series score will be the total of her race scores.

8.2.2 When four races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

9 PRIZES

Prizes will be awarded at the discretion of the Race Committee

10 RIGHTS TO USE NAMES & LIKENESSES

Competitors automatically grant to the organising authority without payment the right in perpetuity to make, use and show any motion pictures, still pictures and live, taped or filmed television of or relating to the event.

11 DISCLAIMER OF LIABILITY

Competitors are entirely responsible for their own safety, whether afloat or ashore, and nothing reduces this responsibility. It is for competitors to decide whether their boat and its helm and crew are fit to sail in the conditions that they might find. By launching or going afloat competitors confirm their boat is fit for those conditions and that they are competent to sail and compete in them. Nothing done by the organisers can reduce the responsibility of the owners and/or competitors, nor will it make the organisers responsible for any loss, damage, death or personal injury, however it may have occurred, as a result of the boat taking part in the racing. The organisers encompass everyone helping to run the event and include the organizing authority, race committee, race officer, safety officer, patrol boat personnel and beach masters. The provision of patrol boats does not relieve owners and competitors of their responsibilities.

12 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3million per event or the equivalent.

13 SOCIAL

13.1 Entrants are invited to join in with club racing on Saturday 7th May. First race start time 0900hrs There is no extra entry fee for this

13.2 The club bar will be open during the event. Contactless payment facilities are in use. Catering and bar facilities will be available to all competitors.
